- ✓ <u>NON-CAFFIENATED CLEAR LIQUIDS ALLOWED the morning of your appointment.</u>
- ✓ NO SOLID FOOD 4 HOURS PRIOR TO APPOINTMENT TIME.
- ✓ NO COFFEE, DECAF COFFEE, TEA, DECAF TEA, HERBAL TEA, SODA, CAFFEINATED BEVERAGES, OR <u>CHOCOLATE FOR 12 HOURS PRIOR TO YOUR APPOINTMENT TIME.</u> Do not take Excedrin, Anacin, caffeine tablets, or other caffeine-containing medications for 12 hours prior to your appointment time.
- $\checkmark$  An IV will be placed when you arrive for the exam.
- ✓ Stop all nitrates 24 hours prior to your test. (See attached list for more information).
- ✓ Please allow 2 to 3 hours to accomplish the scan. Feel free to bring reading material or electronic devices to occupy your wait time involved with the exam.
- Please wear comfortable, loose fitting clothing: shorts or pants and a t- shirt. No metal button, zippers, or jewelry from the waist up. Do not use body lotions or oils on the chest or arms that day.
- ✓ Please be advised, you may be asked to remove your undergarment from your upper body that interfere with the imaging portion of the test. A gown will be provided if needed.
- ✓ If you are taking any medication that contain Aminophylline, Theophylline, Persantine (dipyridamole) or Aggrenox, please stop this medication for 24 hours prior to your appointment time.
- ✓ If you are diabetic and have a morning appointment, hold insulin and/or oral diabetic medication the morning of your test and bring glucometer and insulin/diabetic medication to the appointment.
- ✓ If you are diabetic and have an appointment after 12 pm, eat a light breakfast before 8 am (no caffeinated beverages). Take insulin and/or oral diabetic medication with meal. Bring glucometer and insulin/diabetic medication to the appointment.
- $\checkmark$  If you use inhalers, please bring them with you.
- ✓ Please bring a current list of your medications including dosages.

<u>Important Notice</u>: Failure to cancel the appointment within <u>48</u> hours from the scheduled appointment time, the patient will be responsible to pay for the specific patient ordered nuclear isotope and the pharmacological stressing medication.
